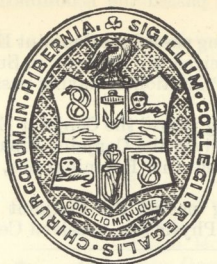

## College.

### *Honorary Fellowship.*

On December 20th, 1906, the Council conferred the Honorary Fellowship on Mr. Priestley Smith, of Birmingham.

### *Representative of the College on the General Medical Council.*

On February 7th, Sir Thomas Myles was elected to represent the College on the General Medical Council.

### *Coat-of-Arms for the College.*

It having come to the knowledge of the Council that the College had no legal right to use the coat-of-arms which has been stamped on all the official documents of the College for very many years, the President was asked to consult Ulster King-of-Arms on the matter. The President was informed that there was no record in the Arms Office of any grant of arms having ever been made to the College; and that under these circumstances the College had no right to use a coat-of-arms. The Council applied for a grant of arms; and as soon as the necessary formalities have been carried out, it will come into use.

### *The Late Mr. Edward Hutton.*

Messrs. Waterhouse & Co., Solicitors, wrote on behalf of Mrs. Darnton Hutton offering to give to the College a portrait of Mr. Edward Hutton, President of the College in 1852. The Council gratefully accepted the offer.

### *Mr. Darnton Hutton's Donation to the College.*

Mrs. Hutton, by desire of her late husband, sent a cheque for £250 as a donation to the College. This sum has been ear-marked to provide a suitable Council Room. The Council at present meet in the Board Room.

### *Aberdeen University.*

This University celebrated the 400th anniversary of its foundation in September, 1906. The President represented this College on the occasion, and presented the following Address :—

Subsequently the College received a vote of thanks from the Chancellor of the University.

*Vaccination Certificate.—Additional Qualification in Vaccination to be obtained by Candidates for appointments as Poor Law Medical Officers.*

In the *Dublin Gazette* of January 5th, 1906, appeared an Order from the Local Government Board amending the Dispensary Rules, and enacting, *inter alia*, that—in addition to being qualified in Medicine, Surgery, Midwifery, and being on the Medical Register—

Such person shall have obtained a certificate of proficiency in Vaccination, given under such conditions as the Local Government Board may from time to time approve, by some person authorized to give such certificates, and recognized by the Local Government Board, and by whom such person shall have been duly instructed and examined in the practice of Vaccination; provided always that such certificate shall not be required to have been obtained by any person who has, on May 1st, 1906, the other qualifications prescribed by this Article.

Under this Order every Fellow and Licentiate of the College who is elected as Medical Officer to any Dispensary District in Ireland must hold this additional qualification in Vaccination, which must be obtained from one of four persons—one in Dublin, Belfast, Cork, and Galway.

On more than one occasion the Local Government Board refused to sanction the election of a Licentiate of this College as a Dispensary Medical Officer, or even as *Locum Tenens*, who had not previously obtained this extra qualification; and ordered a new election.

This Order came into force when Mr. Bryce was Chief Secretary for Ireland, and, by virtue of his office, President of the Local Government Board.



The Council suggested to the Royal College of Physicians, and Trinity College, to ask Mr. Bryce to receive a deputation to point out the great hardships produced by the Order.

Mr. Bryce promised to receive the Deputation, but, though the President made several attempts to have a date fixed, he was unsuccessful.

The Council deputed Sir Arthur Chance and Mr. Donnelly to wait on the Chief Secretary in London. They were received by Mr. Birrell, and were requested to send in a written statement of the facts. This was done.

Subsequently Mr. Birrell received, at his office in Dublin, a joint deputation, representing the Royal College of Physicians, Trinity College, and this College. Mr. Birrell was very sympathetic, but the Council regret to state that so far no action has been taken.

#### *Royal Commission on Vivisection.*

In December, 1906, the Council resolved :—

That the Royal College of Surgeons in Ireland are prepared to support investigations, by methods of experimental research, on animals, and consider such experiments to be absolutely essential to Medical progress.

The President was deputed to appear and give evidence before the Commission.

#### *Meetings held in the College.*

The Council granted the use of the College for meetings of the Royal Academy of Medicine in Ireland, the Irish Medical Association, the Clinical Club, the Irish Branch of the British Dental Association, the Medical Benevolent Fund, the Medical Temperance Society, the King's Coronation National Fund for Nurses in Ireland, and Poor Law Association of Ireland.

#### *Barker Prize for 1906.*

This prize was awarded to Mr. P. G. M. Elvery.

#### *College Dinner.*

The Annual Dinner was held in the Examination Hall on January 26th. Over 182 Fellows and guests were present on the occasion. His Excellency the Lord Lieutenant, the Earl of Aberdeen, honoured the College by his presence.

#### *Bacteriological Laboratory.*

A new Laboratory has been constructed for instruction in this subject.

## Library.

### *Report of the Librarian.*

GENTLEMEN,—I beg to report that the Library is in good condition. Portion of the lower room has had new flooring laid down. The Reading Department has been much used by Fellows, Licentiates, Students, and other members of the Profession now permitted to use the Library. A complete list of the medical periodicals taken by this College, the College of Physicians, Trinity College, and the National Library, has been compiled, and placed in the Library for reference. I think it right to draw the attention of the President, Vice-President, and Council to the necessity of very shortly having to increase the accommodation, owing to the large additions yearly. 206 volumes have been added since last Report: of these 20 were purchased, 95 presented, and 91 periodicals bound.
