REPORT

14th June, 1951.—A Board of Examiners for the Final Dental Examination was appointed to fulfil the requirements of the Dentist's Act, 1928 (Section 39).

All the bodies concerned having approved the recommendations of the Conference held in October, 1950 on the subject of reciprocity, the following notice was published in the medical papers:—

“Reciprocity of Primary Examinations for the Fellowship has been arranged between the Royal College of Surgeons of England, the Royal College of Surgeons of Edinburgh, the Royal College of Surgeons in Ireland and the Royal Faculty of Physicians and Surgeons of Glasgow. Reciprocity is effective as from 1st June, 1951. That is to say candidates who pass the Primary Fellowship Examination of any one of the four corporations after that date will be permitted to proceed to the Final Fellowship Examination of any of the four corporations, subject to complying with the regulations. A “pass” in the Primary Examination before 1st June, 1951 does not entitle a candidate to the benefit of reciprocity.”

12th July, 1951.—Professor H. J. M. Weve of Utrecht was appointed Montgomery Lecturer for 1951.

11th October, 1951.—Mr. R. Atkinson Stoney was appointed a member of the General Medical Council for the term of one year from October 15th, 1951.

Professor Derrick Vail, Chicago, was invited to give the Montgomery Lecture in 1952.

8th November, 1951.—Dr. Davidson was elected Professor of Midwifery and Gynæcology for a period of five years.

Dr. Geoffrey Bewley was elected Professor of Preventive Medicine and Medical Jurisprudence for a period of five years.

Dr. Somerville-Large presented the Council with a framed print of the College.

10th January, 1952.—Mr. W. Q. Wood, F.R.C.S.(Ed.) was appointed external examiner in Anatomy in the Primary Examination for the Fellowship.

Reciprocity with the Royal Australasian College was accepted for the Primary Fellowship Examination.

14th February, 1952.—A telegram had been sent to Her Majesty the Queen Elizabeth in the following terms.

“The President, Vice-President and Council of the Royal College of Surgeons in Ireland desire to express to Your Majesty and to the Royal Family their sincere sympathy in your great loss and sorrow.”


A reply was received from Buckingham Palace stating:
