## ANNUAL REPORT.

---

*Election of Honorary Librarian.* — On the 25th June Mr. Adams A. M'Connell was unanimously elected as Honorary Librarian.

*Presentation to the College.* — Mr. Thomas Bodkin presented a Model of the College.

*Royal Dublin Society.* — The Council granted the use of the Examination Hall to the Royal Dublin Society for the holding of Juvenile and Afternoon Lectures.

*Election of Professors.* — On the 12th July E. M'Dowel Cosgrave was elected Professor of Biology; Evelyn John Evatt was elected Professor of Anatomy; Wm. Caldwell was elected Professor of Chemistry and Physics; John Alfred Scott was elected Professor of Physiology.

*Charter Day Dinner.* — The Charter Day Dinner was held on the 25th July, 1923. The College numbered amongst its guests His Excellency the Governor-General, Dr. W. J. Mayo, of Rochester, U.S.A.; and the Honorary Fellowship was conferred upon Sir Harold Stiles, K.B.E.

*Control of the Medical and Dental Professions.* — On the 4th October a communication from the Ministry of the Local Government Board on the subject of the control of the Medical and Dental Professions was received. A Committee, consisting of the President, Vice-President, and Sir Arthur Chance, was appointed to confer with the Royal College of Physicians, University of Dublin, National University, and Apothecaries' Hall.



*St. Bartholomew's Hospital.*—On the 4th October the Council received the following:—

St. Bartholomew's Hospital and the  
Priory Church of St. Bartholomew the Great,  
London, E.C. 1.

800TH ANNIVERSARY, 1123–1923 A.D.

The President and Governors of the Hospital, the Governors of the Medical College, and the Rector and Churchwardens of the Priory Church unite in thanking the President of the Royal College of Surgeons in Ireland for the greetings which were brought by the hand of Sir William Ireland de Courcy Wheeler, M.D., B.CH., B.A.O., F.R.C.S.I., on the occasion of the celebration of the 800th anniversary of the foundation of St. Bartholomew's Hospital and the Priory Church of St. Bartholomew the Great, West Smithfield, London, by Rahere, in the reign of King Henry I. The address is preserved as a treasured possession amongst the records of the Hospital.

*Royal Academy of Medicine in Ireland.*—On the 8th November a letter was received from the Royal Academy of Medicine in Ireland saying that in future their Meetings would be held in the Royal College of Physicians, and thanking the President, Vice-President, and Council for the accommodation they had afforded them in the past.

*Dental Board of the United Kingdom.*—On the 8th November the Council granted permission to the Dental Board of the United Kingdom for the holding of Dental Lectures.

*Students' Union.*—On the 8th November permission was granted to the Students' Union for the holding of a dramatic performance.

*General Medical Council.*—On the 13th December the following resolution was adopted:—

Resolved—That before expressing an opinion on the future government of the Dental Profession in Ireland, the Council should give their Dental Licentiates and their Fellows who practise Dental Surgery an opportunity of expressing their views to the Council.



*Death of Sir Lambert Ormsby.*—On the 10th January the following resolution was unanimously adopted, and passed in silence :—

That the President, Vice-President, and Council, having heard of the death of their esteemed colleague, Sir Lambert Hempenstal Ormsby, Secretary and Past President of the College, desire to express their sense of the irreparable loss the College has sustained, and to offer their deep sympathy with his family in their sad bereavement.

*General Medical Council.*—Election of Representative.—On the 10th January Sir Arthur Chance was unanimously elected as representative of the College on the General Medical Council.

*Charter Day Dinner.*—The Charter Day Dinner was held on the 1st March, His Excellency the Governor-General being present.

*Lister Memorial Prize.*—On the 10th January the President was appointed to represent the College on the Committee of the Lister Memorial Prize.

*Carnegie Bequests.*—The President kindly undertook to bring under the notice of the Carnegie trustees the inadequate supply of books in our Library.

*Montgomery Lectureship in Ophthalmology.*—A conference was held between the representatives of Trinity College and the Royal College of Surgeons, and the following resolutions received the approval of those present :—

Resolved—That if a distinguished man be appointed Montgomery Lecturer, as has been the practice in recent years, a fee of 100 guineas is an adequate honorarium, and that one public lecture is sufficient.

2. That it is undesirable to appoint such lecturer for a second year.

3. If, however, either electing body think it desirable in any given year to do so, an examination may be held at which registered medical practitioners of not more than two years' standing, who have qualified at a recognised Irish School of Medicine, may present themselves; and on the result of this examination (at which

theses submitted by the candidates may be considered) a Junior Montgomery Lecturer may be appointed, who shall undertake to prosecute, outside Ireland, study or research (at such centres as the electing body may approve) in a particular branch of Ophthalmology, and to give at the end of his year of office (or of each year, if reappointed) an account of his research in a public lecture or lectures.

4. The remuneration of the lecturer in the latter case may be fixed by each electing body according to the funds in its hands.

5. It is not considered necessary to seek for any formal alteration of the terms of agreement reached on the 16th January, 1915, by the Joint Committee of the Royal College of Surgeons and Trinity College.

*Lectures.*—On the 13th March the Council gave permission to Captain Harrison to hold three lectures on Political Economy in the Examination Hall.

*Committee of Management.*—Mr. R. C. B. Maunsell was appointed to represent the College at the Meetings of the Committee of Management.

*Control of Medical and Dental Education.* — On the 20th March a communication was read from the representatives of the College and other bodies appointed to consider the question of Medical and Dental Education, as referred to them by the Minister of the Local Government Board. The conclusion of the conference was as follows:—

We recommend that the present system of Medical and Dental registration should not be altered.

*Montgomery Lectureship.* — The President reported that Mr. E. Treacher Collins had accepted an invitation to deliver the Montgomery Lecture on the 28th May.

*New Ordinance.*—

That on the insertion in the Calendar of the College of an alteration in the name of a Fellow, Licentiate, or Licentiate in Dental Surgery, the Registrar shall retain on the Register the name as already registered unless and until the Council shall otherwise direct.

### *Report of the Librarian.*

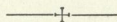
