REPORT

25th May, 1950.—The President, Mr. Wm. Pearson, was chosen to represent the College at the celebrations to be held in London to mark the one hundred and fiftieth Anniversary of the founding of the Royal College of Surgeons of England and to present the address to congratulate the College.

Mr. William Doolin, Secretary, read a draft of the address.

8th June, 1950.—The Executors of the late Lady Woods made a gift to the College of a marble bust by Oliver Shepard of the late Sir Robert Woods, former President of the College: this was set up in the Council room.

After the meeting the President made a presentation on behalf of the Council to Mr. H. S. Meade the retiring President.

15th July, 1950.—Mr. Julian Taylor, O.B.E., F.R.C.S., was appointed external examiner in Surgery for the Final Fellowship examination.

12th October, 1950.—The President spoke of the loss sustained by the Council and the College by the death of William Cecil Plunket Smyly.

Mr. R. Atkinson Stoney was appointed to be a member of the General Council of Medical and Registration for a period of one year.

Professor Jessop was appointed to be the College Representative on the Medical Research Council until January 25th, 1955.

Notice was received from the Incorporated Dental Hospital that in 1952, and after, fifteen places each year would be available for students of our Dental School.

9th November, 1950.—The following motion was passed:

1. That reciprocity of the Primary Fellowship Examinations of the Royal College of Surgeons of England, the Royal College of Surgeons of Edinburgh, the Royal College of Surgeons in Ireland and the Royal Faculty of Physicians and Surgeons of Glasgow, be put into effect at an early date.

2. That the date as from which reciprocity begins be arranged by correspondence when the foregoing recommendation has been approved by all the corporations concerned and that June, 1951, be suggested.
3. That reciprocity shall not be retrospective to the date agreed.
4. That arrangements be made for continued interchange of examiners as a means of equating the standard of the examinations.
5. That every candidate be required to make a declaration that he has not, within three months, sat the examination of any examining body in the subjects of the Primary Examination.
6. That no exemptions be granted to candidates who have taken an Honours degree in Anatomy or Physiology and that the only exemptions to be granted at present should be to those who have passed the Primary Fellowship Examination of the Royal Australasian College of Surgeons, or who, having obtained a higher Australasian degree with a suitable primary examination, have been exempted from the Primary Fellowship Examination of that College.
7. That no further reciprocity of Primary Fellowship Examinations be arranged by any of the parties to this agreement without consulting the others.
8. That a uniform entrance fee of ten guineas be charged for each Primary Fellowship Examination for first admission or re-examination.
9. That no substantial alteration in the regulations be made by any of the corporations without consulting the others.

Miss C. Mathews was appointed on six months probation as Assistant to the Professor of Chemistry and Physics.

14th December, 1950.—Mr. M. P. Burke, Vice-President was accorded the thanks of the Council for his work on obtaining the increased grant from the Minister for Finance.

Mr. Frederick Gill was nominated to be a member of the Committee to be entrusted with the award of the Lister Medal and Honorarium for the year 1951.

Mr. Harold C. Edwards was appointed external examiner in Surgery for the Licence.

8th February, 1951.—Dr. P. D. J. Holland was elected Lecturer in Pathology and Dr. J. Pollock was appointed extra assistant to the Department of Pathology. June 1st, 1951, was accepted as the date upon which the agreement upon reciprocity in the Primary Fellowship shall begin.

8th March, 1951.—The Council received with regret the news of the death of Professor E. J. R. Evatt, formerly Professor of Anatomy.

12th April, 1951.—Dr. R. B. Dockrell, B.D.S., was elected as Lecturer in Orthodontics. A Sub-Committee was appointed to go into the question of acquiring some houses in York Street with the idea of providing a Hostel for students and to find out ways and means for doing this.

LIBRARY REPORT

In the past year, 13,634 books and journals were issued to Students, Licentiates and Fellows. The usual journals were received, and books were added by purchase and donation. Special assistance was given to several post-graduates working on historical and bibliographical subjects.

ANNUAL REPORT ON MUSEUM, YEAR 1950-1951

GENTLEMEN,

I beg to present the annual report on the Museum for the year 1950-51.

During the year some alterations were made in the Museum for the better exposition of the specimens. Glass cases were placed on the window sills allowing a much clearer view of the specimens contained in them.

The Italian wax models and plaster casts were placed in a special show case and now form an exhibit in themselves.

Many other specimens have been cleaned, re-mounted and freshly labelled.

Show boards have been erected at the entrance end of the hall for exhibits of photomicrographs, charts, clinical details and notes with X-ray plates, etc.
