## ANNUAL REPORT.

---

On 13th June, 1928, Mr. W. C. P. Smyly was unanimously elected as Honorary Librarian.

The following is an extract from a letter received from the late Sir Arthur Chance :—

“I am sorry that I will not have the pleasure of ‘sitting under’ you during your term of office, but I may be permitted to congratulate the College on having elected a President so well fitted to guide its destinies at such a critical period.

“I hope that those in whose hands the future of the country lies will realise the influence of the College in creating and maintaining a high standard of professional ethics, and the impossibility of preserving such a standard by purely penal methods.

“I thank you for your welcome to my son as a member of the Council, and I hope that his association with the College, so auspiciously begun, may be a long and useful one.”

On 21st June the President and Council elected the Examiners for the ensuing year.

On 30th July Professor Hugh Hampton Young, of Baltimore, was admitted an Honorary Fellow of the College, and was subsequently entertained to dinner.

It was with profound regret that the Council placed on record the loss they have sustained through the untimely death of their friend and colleague, Mr. Louis A. Cassidy.

On 11th November the President, by direction of the Council, laid a memorial wreath on the R.A.M.C. Memorial in St. Patrick's Cathedral.



On 13th December the Examination Committee recommended that the Richard Dancer Purefoy Memorial Prize be awarded to Dr. Attracta Halpenny.

The use of the Examination Hall was granted to the Royal Zoological Society, to the Incorporated Law Society, and to the 7th British Congress of Obstetrics and Gynæcology.

On 10th January Sir William Taylor was unanimously re-elected to represent the College at the meetings of the General Medical Council.

On 10th January Mr. R. Charles Butler Maunsell was unanimously re-elected to represent the College at the meetings of the Saorstát Medical Council.

The Council is pleased to report that a very satisfactory arrangement has been made for reciprocity with the National Board of Medical Examiners of the United States of America on the same basis as that already in existence with the London Conjoint Board and the Scottish Conjoint Board.

On 10th January the Saorstát Medical Council asked the College to nominate an Examiner in connection with the Dental Examinations about to be held under the new Dentists Act. Mr. D. L. Rogers was unanimously elected.

The Charter Day Dinner was held on the 23rd March.

On the 14th March the Council nominated the Vice-President, Mr. R. Atkinson Stoney, to represent this College in connection with the award of the Lister Memorial Prize.

## Museum.

GENTLEMEN,

I beg to submit the following Museum Report for the past year:—

It will appear that not so much use is being made of the Pathological specimens at our disposal as heretofore, since no specimens have been borrowed by the Professors of Medicine, Surgery, or Physiology for demonstration purposes.

For the teaching of Pathology, the collection has been freely used, scarcely a lecture having been delivered without the demonstration of specimens illustrating the subject of the lecture.

In the matter of fresh specimens added, it has proved rather a lean year, the number of post-mortem examinations performed having been below the average. As long as the main source of supply is limited to a single hospital this is likely to happen.

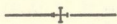
