REPORT

July, 1945.—Mr. N. A. Kinnear having been unable to take the Declaration it was ordered that his election was void and that a new election be held. Mr. Ian Fraser was elected to fill the vacancy.

The officers of the College and Schools who had manned the fire-fighting squads were thanked for their services.

October, 1945.—It was decided (a) that candidates will not be admitted to the Primary Fellowship Examination until at least one year after passing an approved qualifying examination, and that candidates will be required to produce evidence of one year's study of the basic sciences; (b) that candidates will not be admitted to the Final Fellowship until at least three years after passing an approved qualifying examination; and that approved appointments must be held during this period.

Mr. R. Atkinson Stoney was re-elected to serve as representative of the College on the General Medical Council for a period of one year.

December, 1945.—Dr. Widdess resigned his appointments in the College. On the motion of Mr. Wm. Doolin the Council decided to appoint a Lady Dean of Residence to look after the welfare of women students. Mrs. Blake was later appointed to this post.

January, 1946.—The Council passed a vote of condolence with Lady Ball and relatives on the death of Sir C. Arthur K. Ball. Dr. Widdess having asked permission to withdraw his resignation was re-appointed to the posts formerly held by him. It was decided that the Principles of Pathology should be one of the subjects for the Primary Fellowship Examination. Mr. Doolin was appointed to serve on the Editorial Board of the British Journal of Surgery.

February, 1946.—Dr. Pollock was appointed Lecturer and Senior Assistant in Pathology.

Mr. Wm. Doolin was nominated a representative governor of the Imperial Cancer Research Fund for a period of three years.

March, 1946.—The Council recorded its thanks to Mr. W. C. P. Smyly for the gift of some 300 books and a collection of old surgical instruments. Among the books are several in manuscript, including John Hunter's lectures in the hand of Sir Philip Crampton, and case notes taken at the Meath Hospital. Instruments for ear, nose and throat work, lithotrites, some early anæsthetic apparatus for hypodermic medication are noticeable features of the instrument collection. These will be displayed from time to time in the Library.

LIBRARY.

GENTLEMEN,

During the past year 4,509 books and periodicals were issued to borrowers. The usual journals were received, and books were acquired by purchase and donation.

The following gifts were received :—

C. P. Smyly, Esq., F.R.C.S.I.—Several hundred old medical books, including some interesting manuscript, lecture and case notes. An extensive collection of old surgical instruments.

R. Cusack, Esq.—A medallion, framed, of the head of his ancestor James William Cusack, President of the College in 1827, 1847 and 1853. It was executed in 1862 by J. S. Wyon, Chief Engraver of Seals, for the Cusack Prize Medal at Dr. Stevens' Hospital.

C. Somerville-Large, Esq., F.R.C.S.I.—A Treatise on the Pathology, Treatment and Diagnosis of Neurofibroma R. W. Smith. Dublin 1849; A Guide to Operations on the Brain. Alec Fraser. London, 1890; Miscellaneous coloured Anatomical Plates.

T. Carty, Esq., M.B.—A number of 19th-Century medical text-books.

Henry Hunt, Esq., M.D.—Tables of the Skeleton and Muscles of the Human Body. B. S. Albinus. London, 1749.

W. R. LeFanu, Esq., M.A. (Librarian, Royal College of Surgeons, London)—A copy of his work; A List of Books by John Hunter. Cambridge, 1946.

The above donations are much appreciated, and it is to be hoped that the Library will continue to benefit in this way. Owners of books, manuscripts and other material of interest in relation to medical and surgical history may be assured of their permanent preservation should they decide to place them in our collection.

Owing to rearrangement in the Library, several thousand volumes had to be removed, accommodated on new shelving and the catalogue place-markings altered. This work is now completed. The arrangement of the Periodical and Reference Room has also been carried out.

Exhibitions of books, etc., of interest in connection with the history of the Surgery of Head Injuries, and Microscopy from the 17th to 19th centuries were arranged during the past year.

GENTLEMEN,

I have the honour to submit the following report on the Museum for the year 1946.

Specimens were placed at the disposal of different examiners in other subjects as in previous years.

The difficulties as regards mounting jars and preserving solutions continue as during the war years, but nevertheless the following specimens were added during the year :—

Heart with syphilitic aortitis. (Dr. Lewis).

Aneurysm descending aorta. (Dr. Lewis).

Heart with calcified ball thrombus.

Ghon focus in lung of infant with miliary spread in spleen.

Tubal Pregnancy. (Dr. Spain).

Hydronephrosis bilateral.

Portal pyæmia. (Mr. Chance).

The bilateral hydronephrosis was discovered by a student in the dissecting-room and Professor Evatt very kindly allowed me to preserve the specimen.

A number of gross unmounted specimens from different sources were available for demonstrations.

A set of lantern slides illustrating various aspects of Melanosis Coli was presented by Dr. Roden.
