Occasions on which the President represented the Council.

CANCER RESEARCH FUND.

At the Council meeting on July 4th the President reported that he had attended the Annual Meeting of this Fund at Marlborough House on July 1st, when H.R.H. the Prince of Wales presided, and that he had seconded the adoption of the Report on that occasion.

ROYAL COMMISSION ON VIVISECTION.

In June the President attended, on part of the Council, before the Royal Commission on Vivisection, and gave evidence in support of investigations by methods of experimental research, in accordance with Resolution of Council, December, 1906.

The President was nominated to represent this College on a deputation to the Home Secretary, to protest against the departmental restrictions now imposed on Vivisection by the Home Office.

NOTIFICATION OF TUBERCULOSIS.

The President represented the College on a deputation which waited upon His Excellency the Lord Lieutenant, to advocate the compulsory notification of all cases of Pulmonary Tuberculosis.

Representative of the College on the General Medical Council.

On February 6th Sir Thomas Myles was elected to represent the College on the General Medical Council.

Bookey Mortgage.

At the Council meeting on March 19th, a letter was received from the College solicitor, stating that this mortgage had been paid off and the proceeds invested in Consols. This will cause a reduction in the income of the College.

Coat-of-Arms for the College.

It was stated in last year's Report that the Council had applied for a Grant of Arms, and the patent has been received.

Vaccination Certificate—Additional Qualification in Vaccination to be obtained by Candidates for appointments as Poor Law Medical Officers.

As mentioned in last year's Report, Mr. Birrell received a deputation representing the Royal College of Physicians, Trinity

College, and this College. A reply was received by the President on August 1st, stating that in the opinion of the Chief Secretary the order should continue in force.

The Irish Universities Bill, 1908.

At the Council meeting on January 6th, it was resolved that the Chief Secretary be requested to receive a deputation for the purpose of representing to him the injury likely to be caused to this College and its School, as the result of the new University in Dublin, and to ask him to make provision for the due maintenance of the School.

The Chief Secretary requested to be supplied with a statement setting out the grounds upon which the President and Council apprehended serious injury and loss to the College and its School.

A statement was prepared and sent to Mr. Birrell; and the Council are hopeful that due provision will be made by Government for the College School.

Both the Royal Colleges (Physicians and Surgeons) in London have passed resolutions expressing admiration for the work done by the College in the past, and hoping that adequate provision would be made to enable it to continue its work in the future.

Museum.

Report of the Curator.
