## ANNUAL REPORT.

*Election of Honorary Librarian.*—On the 10th June Mr. A. A. M'Connell was unanimously elected as Librarian.

On 10th June the election of Professor of Physiology was postponed, and Dr. Fearon was nominated to carry on the work, pending election.

*Election of Examiners.*—On the 17th June the President and Council elected the Examiners for the ensuing year.

*Presentation to Mr. R. C. B. Maunsell.*—Mr. R. C. B. Maunsell, outgoing President, was presented with a silver salver by his colleagues on the Council in recognition of the admirable manner in which he had discharged the onerous duties of President during his term of office.

On 15th July the President, Vice-President, and Council resolved to offer their hearty congratulations to Sir Berkeley Moynihan on the recent honour which had been conferred upon him, viz., his election as President of the Royal College of Surgeons of England.

*Death of the Professor of Surgery.*—It was with deep regret that the Council learnt of the death of Professor G. Jameson Johnston, who had served so long and faithfully both as a member of Council and as Professor of Surgery. A resolution of sympathy with Mrs. Johnston in her bereavement was unanimously adopted.

*Temporary Professors of Surgery.*—Pending the election of the Professor of Surgery, Mr. Arthur Chance, F.R.C.S.I., and Mr. Henry Stokes, F.R.C.S.I., were asked to deliver the necessary lectures.

In response to a letter from Mr. L. A. Cassidy, F.R.C.S.I., Hon. Secretary to the Irish Cancer Research Committee, asking the Council to nominate two members as representatives of the Royal College of Surgeons in Ireland on that Committee, it was unanimously decided to nominate Mr. T. E. Gordon and Sir William Taylor to represent this College.

It was decided to change the day of meeting from the second Thursday in each month to the second Wednesday in each month, to suit the convenience of the President.

Mr. M'Connell on 23rd November resigned his position as Member of the Council in order to become a candidate for the Professorship in Surgery.

*Election of Professor of Surgery.*—Mr. A. A. M'Connell was appointed Professor of Surgery on 9th December.

On the 14th January Sir Arthur Chance was unanimously re-elected to represent the College at the meetings of the General Medical Council.

*Charter Day Dinner.*—The Annual Charter Day Dinner was held on the 19th February. Quite a large number of guests came from Belfast and neighbourhood to attend the Dinner.

The use of the Examination Hall was granted to the Royal Zoological Society for the holding of their annual meeting.

*Presentation by Professor Tweedy.*—Professor Tweedy presented a number of valuable Midwifery and Gynæcological charts for use in the teaching of students, which were gratefully accepted.

On an invitation from the Royal Society asking the Council to nominate a representative to take part in the

Centenary Celebrations of the Birth of Lord Lister, Mr. Andrew Fullerton (President) was appointed to represent the College.

*Lane Pictures.*—In response to a letter from Lord Granard concerning the Lane pictures, it was decided to send the following resolution:—

“That the President, Vice-President, and Council of the Royal College of Surgeons in Ireland are unanimously of opinion that the delay in carrying out the wishes of the late Sir Hugh Lane has created an increasing sense of the unfairness of retaining his collection of pictures in England. That the President, Vice-President, and Council therefore venture to press upon the Government of the Saorstát the importance of taking early action in the matter.”

The use of the Examination Hall was granted to the National Society for the Prevention of Cruelty to Children for the purpose of holding their annual meeting.

The National Cancer Campaign was granted the use of the Examination Hall for the purpose of holding a meeting.

*Medical Practitioners' Bill.*—A deputation consisting of the Vice-President (Mr. T. E. Gordon), Sir Robert Woods, and Mr. R. C. B. Maunsell, was appointed to wait on the Minister for Industry and Commerce to urge the claims of the Royal College of Surgeons in Ireland for separate representation on the proposed Saorstát Medical Council. In the unavoidable absence of Mr. Gordon, Sir Robert Woods and Mr. Maunsell interviewed the Minister for Industry and Commerce and the Minister for Justice, and received a sympathetic hearing. Subsequently, the Bill was amended by the Minister for Industry and Commerce so as to give separate representation to the Royal College of Surgeons.

In this connection it will be of interest to the Fellows to know that since August, 1925, the representatives of this College have been in frequent consultation with the Government, and the principle of the Bill as suggested by the representatives of the College has now been embodied in the Medical Practitioners' Bill. The aim of the College all through the negotiations in regard to the Medical Practitioners' Bill was to secure to all Medical Practitioners educated in this country the right to register their qualifications on the register of the General Medical Council.

*Finance.*—The Council regrets that the financial position of the College has given rise to considerable anxiety, and trusts that the efforts of the sub-committee appointed to investigate every item of expenditure and income may have favourable results.
