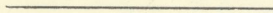

ANNUAL REPORT.

July, 1934.—Resignation of Professor Synge as Professor of Medicine. The College accepted his resignation with regret, and thanked him for his services rendered.

November, 1934.—Election of Professor of Medicine. Dr. Leonard Abrahamson was elected Professor of Medicine, to hold office during the pleasure of the Council. Provided that, if the Council shall not before the expiration of five years from the date of commencement of such appointment terminate the same, the said Professorship shall on the expiration of such period of five years become vacant.

The Council decided that any children of a Fellow or Licentiate of the College, or any Doctor practising in Ireland, should be allowed a reduction of School fees to Fifty Guineas, if paid in two moieties, at the commencement of the first and third years.

Application received from the Richmond, Hardwicke, and Whitworth Hospital, asking for recognition of the Ophthalmic Department of that Hospital. The Council acceded to their request.

The following gifts were presented to the College:—A bust of Edward Jenner, from Miss K. E. Johnston, and a portrait of Dr. Crawford Long, of Georgia, the first man to administer Anæsthetics, by Mrs. Foy.

Election of Sir Thomas Myles. Sir Thomas Myles was appointed to represent the College at the meetings of the General Medical Council.

Election of Mr. R. Atkinson Stoney. Mr. R. Atkinson Stoney was re-appointed to represent the College at the meetings of the Saorstát Medical Council.

February, 1935.—Dr. R. H. Micks was appointed Professor of Pharmacology, to hold office until the pleasure of the Council. Provided that, if the Council shall not before the expiration of five years from the date of commencement of such appointment terminate the same, the said Professorship shall on the expiration of such period of five years become vacant.

February, 1935.—Mr. Seton Pringle, President, was nominated to represent this College as to the Award and Honorarium to be granted in the year 1936 in connection with the Lister Memorial Fund.

By an arrangement with the Royal College of Physicians it was decided to establish a Diploma in Ophthalmic Medicine and Surgery.

May, 1935.—Mary Louisa Prentice Montgomery Lecture. The fifth lecture was delivered by Mr. R. Affleck Greeves, F.R.C.S.

Formal permission was given to a number of Societies to hold their meetings in the College, including the Association of the Royal College of Surgeons in Ireland, Royal Zoological Society, Irish Medical Association, Irish Hospitals Trust, Women's National Health Association, etc.

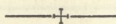
