On the occasion of the celebration of the Bicentenary of the School of Physic, the following Address was presented, on behalf of the College, to the University of Dublin, by the President, Vice-President, and Secretary :—

ADDRESS FROM THE ROYAL COLLEGE OF SURGEONS IN IRELAND TO THE UNIVERSITY OF DUBLIN.

WE, the President, Vice-President, and Council of the Royal College of Surgeons in Ireland, have the honour to convey to the University of Dublin our cordial congratulations on the occasion of the celebration of the Bicentenary of the School of Physic. There has always existed a close bond of union between the Royal College of Surgeons and your time-honoured Institution, many of our Fellows having received their training within its hallowed walls.

We recognize with admiration the devoted labours of many generations of illustrious teachers who have contributed so much to the advancement of knowledge, and the enlightenment and progress of the Irish people ; with pride we recall the names of Macartney, Harrison, Stokes, Adams, Apjohn, Smith, Bennett, Banks, Allman, Cunningham ; and we feel confident that their successors will uphold the ancient and honourable traditions of their beloved Alma Mater.

The centuries which have elapsed since the foundation of the University have seen fundamental changes in the constitution, objects, and methods of all educational institutions ; but, during all its vicissitudes, the University has held aloft the lamp of learning, and has produced men famous in philosophy and the liberal arts.

We would further venture to record our high appreciation of the valuable services rendered by the School of Physic to the community by its scientific work in connexion with Preventive Medicine, and by the training of those desirous of service in the Public Departments.

Lastly, we would offer to the University of Dublin our best wishes for the success of its present commemoration, and we would like to express the pleasure it gives us to join with the University in rejoicing on this occasion.

On that occasion the University conferred on the President of the College, Mr. R. D. Purefoy, the degree of LL.D. (*Honoris Causa*).

On October 17th the Council received the following resolution adopted by the Board of Trinity College :—

The Board of Trinity College desire to express their thanks to the President and Fellows of the Royal College of Surgeons in Ireland for their hearty co-operation at the time of the Bicentenary Celebration of the Medical School of Trinity College in July last ; more especially the action of the Royal College in conferring a number of Honorary Fellowships upon some of the distinguished guests of the University, has given extreme gratification to the authorities of Trinity College.

Honorary Fellowships.

At a meeting of the College, held on July 4th, 1912, the Honorary Fellowship of the College was conferred on Mr. Irvine Heward Cameron, of Toronto ; Mr. Robert Jones, of Liverpool ; Sir William Macewan, of Glasgow ; and Sir Henry Morris, Bart., of London.

At a meeting of the College, held on February 1st, 1913, the Honorary Fellowship of the College was conferred on Sir Berkeley Moynihan, of Leeds ; and on Surgeon-General Sir Launcelot Gubbins, Director-General Army Medical Service.

Death of Sir William Thornley Stoker, Bart., and Sir Henry Rosborough Swanzy—past Presidents of the College.

The Council regret to report the great loss sustained by the College through the deaths of Sir Thornley Stoker, Bart., who was President in 1894 and 1895, and for many years Professor of Anatomy in the Schools of Surgery, and Member of Council ; and also of Sir Henry Swanzy, who was President of the College in 1906 and 1907, and a Member of Council for several years, and to whose energy and foresight the Schools of Surgery are indebted for the annual grant obtained from the Department of Agriculture and Technical Instruction.

Address before the College, by Mr. H. Macnaughton-Jones, F.R.C.S.I.

On November 20th, 1912, Mr. H. Macnaughton-Jones gave an Address before the College on the Collection of Pathological Preparations which he had presented to the Museum.

At the conclusion of the Address, which was well attended, a cordial vote of thanks was passed to Mr. Macnaughton-Jones.

Carmichael Prize Essay.

There was only one essay submitted. The adjudicators awarded the Prize to Mr. H. Nelson Hardy, F.R.C.S. Edin.

The Barker Anatomical Prize for 1912.

This Prize was awarded to Mr. Maurice Shipsey, a pupil in the College School.

Election of Honorary Librarian.

Mr. R. Bolton M'Causland was re-elected Honorary Librarian.

Election of Secretary to the Council.

On the 6th June Mr. Charles M. Benson was re-elected Secretary to the Council.

General Medical Council and the Preliminary Examination.

The proposals of the General Medical Council with regard to our Preliminary Examination in General Education were alluded to at length in our Report of last year.

In June, 1912, the proposed regulations came before the Education Committee of the General Medical Council. Although they were strongly resisted by our representative, they were adopted virtually without modification. Later, they were received and entered on the Minutes of the General Medical Council, but no suggestion was made to adopt the report.

At the November Session of the General Medical Council, by the courtesy of Dr. Little, the Chairman, a meeting of the Irish Branch was called, and the following Resolution was passed unanimously :—

That in the opinion of the Irish Branch Council, it is not desirable to alter the present standard of the Preliminary Examination in General Education as held by the Royal Colleges in Ireland, and we therefore recommend that after the words "Government and University Bodies," in the twentieth and twenty-first lines on page 309 of the report of the Education Committee Minutes, vol. xlix., the following words be inserted :—"or of the Royal Colleges of Physicians and Surgeons of Ireland."

Since the passing of that Resolution no action was taken in November by the General Medical Council with regard to the matter, pending inquiries by the Education Committee with regard to the recognized Preliminary Examinations held outside the United Kingdom.

In November Sir Charles Ball was appointed to the important office of Chairman of the Examination Committee. This is one of the two great Committees of the Council, and it is of much importance that its guidance should be in the hands of one thoroughly cognisant of the somewhat intricate problems of Irish Medical

Education. The Council unanimously passed the following Resolution :—

That we congratulate Sir Charles Ball, formerly Representative of the College, on his appointment to the important office of Chairman of the Examination Committee of the General Medical Council.

The Council unanimously passed a vote of thanks to Dr. James Little, Chairman of the Irish Branch Council, for the valuable help and support given to our Representative.

Representative of the College on the General Medical Council.

On October 3rd Sir Arthur Chance resigned the office of Representative on the General Medical Council, and on November 21st was re-elected thereto.

On February 6th Sir Arthur Chance was re-elected to represent the College on the General Medical Council for one year.

Regulations for the Primary Fellowship and License Examination Revised.

The regulations for the Primary Fellowship Examination have been revised, so as to include a practical examination in Physiology. The revised regulations come into force in March, 1914.

The regulations for the Examination for the License of the College have also been revised, so as to include Surgical Anatomy and Surgical Pathology.

Election of Examiner vice Mr. R. J. Montgomery, deceased.

On July 25th Mr. Sydney Young, sc.d., f.r.s., was elected Examiner in Chemistry on Court A, and Mr. Maurice R. Hayes, f.r.c.s., was elected Examiner in Chemistry and Physics on Court B, to act until the following May.

Proposed Pathological Laboratory.

The Council regret having been unable as yet, through want of funds, to carry out the building of the new Pathological Laboratory, plans for which had been considered and adopted. The initial outlay would have amounted to £1,500.

Department of Agriculture and Technical Instruction.

The Council have pleasure in stating that an increased grant was obtained this year from the above Department in support of the College School.

Penal Cases.

On December 5th the name of Mr. William Arnold Thomson was erased from the Roll of Fellows and from the Roll of Licentiates, and the name of Mr. Alfred Arthur Austin was erased from the Roll of Licentiates of the College.

Resignation of Diploma.

On July 25th Mr. E. Thistlewood resigned his Diploma as Licentiate in Dental Surgery. The resignation was accepted, and his name removed from the College Rolls.

Bequest by the late Mr. R. J. Montgomery, F.R.C.S.I.

The late Mr. Montgomery has bequeathed the sum of £5,000 to found a Lectureship in Ophthalmology, to be held alternately for five years, by Dublin University and this College. The Council are in communication with the Board of Trinity College as to the best method of carrying out the terms of the will.

Meetings held in the College.

The Council granted the use of the College for meetings of the Royal Academy of Medicine in Ireland, the Irish Medical Association, Royal Medical Benevolent Fund Society, the Clinical Club, the Irish Branch of the British Dental Association, the Association of Fellows, the King's Coronation National Fund for Nurses, and the Dublin County Borough Medical Committee.

Charter Day Dinner.

On February 1st the Annual Charter Day Dinner, which was largely attended, was held in the Examination Hall. His Excellency the Lord Lieutenant, the Earl of Aberdeen, honoured the College by his presence.

Library.

Report of the Librarian.

GENTLEMEN,—I have the honour to report that the Library has been extensively taken advantage of during the past year by Fellows, Licentiates, and Students. There has been an increased attendance of the students during the year, which I attribute to two reasons—to the greater number of books now available for their use, and to the more comfortable condition of the reading-room, brought about by the remodelling of the heating apparatus.

Report of the Curator.

GENTLEMEN,—During the past year the remounting of the pathological specimens on the Gallery was proceeded with, and there now remains to be done only the contents of four cases.

Dr. Macnaughton-Jones has added to the collection which he presented two years ago four specimens, one of which is a Ganglionic Neuroma, the first tumour of its kind reported in Great Britain. A small album, containing several drawings of the naked eye, and microscopic appearances of this rare tumour, together with a report of the case, accompanied the specimens.
