ANNUAL REPORT

June, 1931.—Mr. W. C. P. Smyly was unanimously re-elected as Hon. Librarian.

July, 1931.—Election of Professors. Dr. L. Abrahamson was elected Professor of Pharmacology, and Dr. A. H. Davidson Professor of Midwifery and Gynæcology.

The Hon. Fellowship of the College was conferred upon Dr. G. E. Armstrong, of Montreal, and Sir Hugh M. Rigby, Surgeon to His Majesty the King.

November, 1931.—The Royal Army Medical Corps Memorial Committee asked the Council to place a wreath on the memorial tablet in St. Patrick's Cathedral.

December, 1931.—Sports Ground. The lease of the sports ground having expired, the Council decided to acquire a new ground, and that the Purefoy Memorial Fund be utilized for this purpose, the erection of a pavilion, and the laying out of the ground. The Council were fortunate in acquiring fields at Bird Avenue, Clonskeagh.

The Council is happy to report the revival of the Students' Union, and there is much activity amongst the various Societies in connection with the College. A very successful Biological Association meets from time time to time.

January, 1932.—Association of the Royal College of Surgeons in Ireland. A number of the past students of the College met together to consider the desirability of forming an old scholars' association, and as a result of their meeting the Association of the Royal College of Surgeons was formed. The objects of the Association are as follows:—

- (a) To forward the interests of the College, its institutions, and any of its members.
- (b) To encourage intercourse between members.
- (c) To keep and circulate a register of its members.

The membership is as follows:—

Membership shall be open to all those whose names have been at any time on the books of the Royal College of Surgeons in Ireland as students, licentiates, diplomates, fellows, or officials of the College.

The admission of members shall be by ballot of the Committee. At an election of a candidate, seven at least must vote; one black bean in six to exclude.

Candidates for admission must be twenty-one years of age or over, and must be proposed by one member of the Association and seconded by another, to both of whom the applicant is personally known; and the candidate's name shall be forwarded to the honorary secretaries, who shall communicate same to each member of the Committee at least seven days before the next meeting of the Committee.

The Council have given this new Association its warm approval.

The Council granted the use of the College to various Societies for the holding of meetings—the Royal Zoological Society, the Women's National Health Association, the Dublin Musical Society.

Sir William Taylor was elected to represent the College at the meetings of the General Medical Council.

Mr. R. Atkinson Stoney was elected to represent the College at the meetings of the Saorstát Medical Council.
