The College.

Parliamentary Grant.

The President and Council in last year's Report regretfully informed the Fellows of the College that they had been unsuccessful in their efforts to obtain a Parliamentary Grant for the Medical School of this College.

Notwithstanding the strenuous efforts of the President and Council during the past year, the School of this College continues to be the only School of Medicine in Ireland which does not receive any income derivable from State aid. It is intended to continue to press this just claim of the School on the Government.

Royal Humane Society's Medal.

This Society awarded Mr. A. Sheridan, L.R.C.S.I., their bronze medal for gallantly saving the life of a man who was being carried out to sea while bathing near Westport. At the request of the Society's representative in Ireland, the President presented the medal to Mr. Sheridan at the Council Meeting on January 20th, 1910.

Vote of Congratulation.

The Council passed a resolution on March 3rd, 1910, congratulating Sir Thomas Myles on his appointment as Surgeon to the King in Ireland.

Representative of the College on the General Medical Council.

On February 3rd, 1910, Sir Thomas Myles was elected to represent the College on the General Medical Council.

New Fellowship Regulations.

On the 1st January, 1910, the new regulations for the examination for the Fellowship became operative. By these new regulations the former division of candidates into two grades has been terminated. It was felt by the Council that it was unfair to the candidates in Grade I, who had obtained their Fellowship Diplomas after a most searching examination, that similar Diplomas could be obtained by older men on less stringent tests. Henceforward there will be only one type of examination for all classes of candidates.

In this connexion it may be mentioned also that the Council has abolished the system previously in force of granting special examinations for the Fellowship at other than the stated periods. The Council has felt that it was not consistent with the dignity of its Fellowship Diploma that examinations for it should be held at irregular dates, merely to suit the convenience of individual candidates.

The School.

During the past year a large sum of money, amounting to nearly £1,400, has been expended on the Anatomical Department, the most important department in every medical school. The old floor, saturated with disease germs, has been replaced by one more in accordance with modern ideas. A new system of ventilation has been installed, new tables of modern type have been supplied, the walls have been thoroughly cleansed and re-painted, the preparation room completely renovated, and large preserving tanks have been provided for the convenience of the Anatomical Class. The Council hopes that this expenditure will be fruitful in result, and will, by the increased facilities for study now afforded, raise the general standard of anatomical knowledge amongst the College students.

Death of Professor A. Fraser.

With feelings of profound regret the President and Council inform the Fellows of the death of their late Professor of Anatomy. Shortly after the annual Election of Examiners in May, 1909, Professor Fraser's health broke down; and he went to Lossiemouth, hoping that the change to his native air would so restore his health that he would be able to resume duty on the opening of the ensuing Winter Session in October. Unhappily the disease progressed rapidly; and he passed away at Lossiemouth on July 25th, 1909, having filled the chair of Anatomy for almost twenty-six years.

The loss which the School of the College has sustained by Professor Fraser's early death cannot be exaggerated. By his untiring energy, by his devotion to his work, and by his unflagging interest in his pupils' welfare, he won the affection and respect of the College students, by whom and by his colleagues on the professorial staff, as well as by the members of the Council, his memory will long be cherished.

Mrs. Fraser's Civil List Pension.

After the death of the late Professor Fraser it was ascertained that he had not been able to make any provision for his widow; the entire of his income after defraying his actual living expenses having been spent on his research work.

At the Council Meeting on November 4th, 1909, a memorial was approved praying the Prime Minister to grant Mrs. Fraser a pension from the Civil List.

His Excellency the Earl of Aberdeen most kindly undertook to present the memorial in person, and to use his influence in its favour.

The memorial was supported by many of the most distinguished medical and scientific men in the United Kingdom. As the result of these combined efforts the President was able to announce to the Council at its last meeting in February that a grant of £70 a year had been made to Mrs. Fraser.

Election of a Professor of Anatomy.

At the Council Meeting on October 7th, 1909, Mr. A. Campbell Geddes, M.D., CH.B., EDIN., was elected Professor of Anatomy; and Mr. Norman Cecil Rutherford, M.B., CH.B., EDIN., F.R.C.S. ENG., was elected assistant to the Professor of Anatomy.

The Deed of Amalgamation.

Owing to the lamented death of Professor Fraser, there are now only two surviving charges on the General Fund created by this Deed, viz.:—those referring to Professor Scott and the College Registrar.

For more than twenty years the College has had to struggle under the burden placed upon its shoulders by the Deed of Amalgamation. At length there is a prospect of this burden being got rid of.

Negotiations are now on foot, which it is hoped will, if completed, restore to the College its former liberty of action, and enable it to act vigorously in support of its school, by taking such measures as it may deem necessary to raise the standard both of equipment and teaching.

Special Reserve of Officers, Royal Army Medical Corps.

On July 14th, 1909, the Council received a letter from the Director-General asking the President and Council to bring the conditions of service in this reserve before the students under their care.

The students responded with alacrity as soon as they were informed of the proposal; and a branch of the officers' training corps for the supply of junior medical men for the special reserve of the Army Medical Corps has been established in connexion with the Schools of Surgery of the College.

Students' Union.

At the Council Meeting on December 23rd, 1909, at the suggestion of Professor Geddes, the Council sanctioned the formation of a Students' Union, and placed the Albert Hall at their disposal.

This Hall has now been fitted up as a billiard-room and reading-room, and being well supplied with newspapers, periodicals, &c., the Council trusts it will become, not merely a convenience to the students working in the School, but will help to give them a sense of partnership in the College, which will in turn maintain and strengthen the bonds which unite the College with its future Licentiates and Fellows.

Barker Prize for 1909.

This Prize was awarded to Mr. Harman R. Tighe. Mr. J. S. Pegum was awarded an additional Prize.

Meetings held in the College.

The Council granted the use of the College for meetings of the Royal Academy of Medicine in Ireland, the Irish Medical Association, the Clinical Club, the Irish Branch of the British Dental Association, the Medical Benevolent Fund, the Medical Temperance Society, the King's Coronation National Fund for Nurses in Ireland, the Poor Law Association of Ireland, and Irish Nurses' Association.

College Dinner.

The Annual College Dinner, which was to have been honoured by the presence of His Excellency the Earl of Aberdeen, had to be abandoned for this year owing to the lamented death of our beloved Sovereign, His Majesty King Edward VII.

Library.

Report of the Librarian.

GENTLEMEN,—I beg to report that the Library continues to be much used by Fellows, Licentiates, Students, and other members of the profession, who are always permitted to read therein, subject to the rules laid down by the Council.

Museum.

Report of the Curator.

GENTLEMEN,—Considerable progress has been made during the past year in the reorganization of the Museum.

On the ground-floor the skeletons of the Wild Boar, Tapir, Nylgau, and Hippopotamus have been remounted. The stand for the latter is not yet complete. In other words, all the skeletons on the floor, with the exception of the two elephants, have been thoroughly overhauled and remounted; and as a consequence the collection is now, in so far as skeletons of the larger mammals are concerned, unrivalled in Ireland.

In the Gallery a very large number of the pathological specimens comprised in the Respiratory, Alimentary, and Urinary sections have been remounted. This has been a wearisome and tedious task, as with most of the bottled specimens the spirit has had to be renewed times without number, owing to the repeated yellowish discoloration of the fluid, due to the fact that such specimens had been put up in the first instance without having been properly cleaned and hardened.

Specimens were received during the year from Dr. W. Boxwell, Captain Coppinger, I.M.S., Drs. E. F. Hanrahan, Lennon, Sir John Moore, Dr. Macdougall, Professor Scott, and Mr. W. Taylor.
