

## SEVENTY-SEVENTH ANNUAL REPORT OF THE COUNCIL.

## The College.

### *Election of Hon. Librarian.*

On 5th June, 1919, Mr. R. Bolton M'Causland was re-elected Hon. Librarian.

### *Veneral Diseases Act.*

On 5th June, 1919, a new Agreement was entered into with the Dublin Corporation in connexion with this Act.

### *Dublin Castle Red Cross Hospital.*

On 19th June, 1919, Dublin Castle Red Cross Hospital presented a complete X-Ray Apparatus for use in the Schools.

### *Macnaughton-Jones Bequest.*

On 3rd July, 1919, a sum of £230 was received from the Executors of the late H. Macnaughton-Jones to provide the funds necessary for a medal to be styled "Macnaughton-Jones Medal in Obstetrics and Gynæcology."

### *Death of Richard Dancer Purefoy, Past President.*

On 3rd July, 1919, the following resolution was adopted :—

"That the President, Vice-President, and Council of the Royal College of Surgeons in Ireland deplore the death of their friend and colleague, Dr. Richard Dancer Purefoy, who was ever ready to place his services at the disposal of the College; and they hereby convey an expression of their deepest sympathy with Miss Purefoy and the several members of her family in their bereavement."

### *Veneral Diseases Act.*

On 17th July, 1919, an Agreement was entered into with the Dublin County Council.

### *Resignation of Professor R. Travers Smith.*

On 16th October, 1919, Professor Travers Smith tendered his resignation of the Chair of Materia Medica. The resignation was accepted with regret.

### *Sir Charles A. Cameron.*

On 29th November, 1919, Sir Charles A. Cameron was entertained to a Complimentary Dinner on his entering on his ninetieth year.

*Honorary Fellowship.*

His Royal Highness the Duke of Connaught and Strathearn was graciously pleased to accept the Honorary Fellowship of the College. The conferring has not yet taken place.

*Vacancy on Council.*

On 5th December, 1919, Major-General R. H. Sawyer was unanimously elected to fill the vacant position on Council.

*Charter-Day Dinner.*

The Charter-Day Dinner was held on 17th April, 1920.

*Montgomery Lectureship.*

Professor Grafton Elliott Smith, M.A., M.D., F.R.C.P., F.R.S., was unanimously elected to the Mary Louisa Prentice Montgomery Lectureship in Ophthalmology. The subject of his first lecture will be "The influence of stereoscopic vision on the evolution of man." The lecture will take place in October, 1920.



*Meetings held in the College.*

The Council granted the use of the College for meetings of the Royal Academy of Medicine in Ireland, the Irish Medical Association, Royal Medical Benevolent Fund Society, Irish Medical Committee, Dublin Clinical Club, Irish Branch of the British Dental Association, British Red Cross Society, Research Defence Society.

*Myles and Dwyer v. The College.*

This case was settled by mutual consent, the defendants to pay the costs up to and including interlocutory injunction only.

*Officers' Training Corps.*

The Officers' Training Corps has been well maintained during the past year. With the consent of the War Office, a Medical Unit has been formed, so that the College now possesses two Units.


