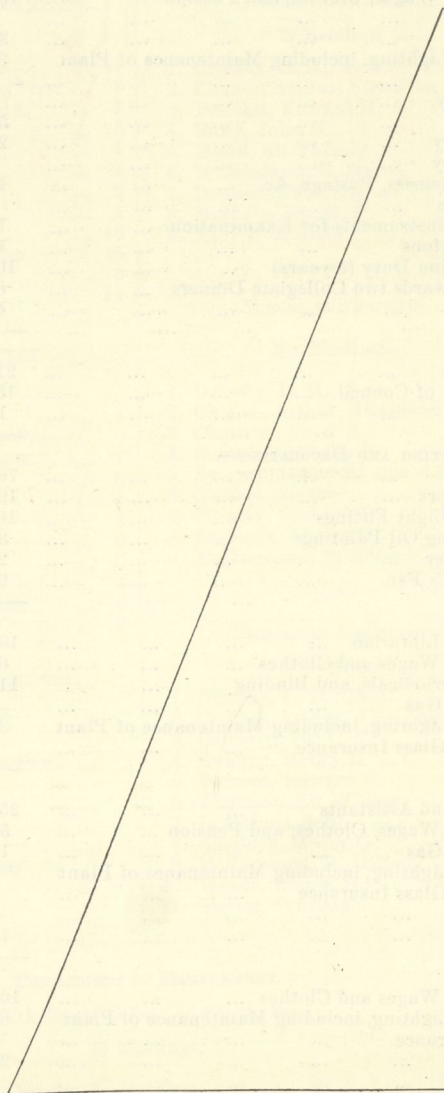

AUDITORS' CERTIFICATE.

We have audited and vouched the foregoing Accounts, and certify them to be correct.

The Receipts for the year show a decrease of £456 4s. 6d. as compared with those of last year. This decrease occurs principally in the Fellowship Fees, which were in the previous two years abnormally high. Although the ordinary expenses were £677 6s. 7d. less than the receipts, there is an increase in the combined expenditure for the year of £1,312 4s., as compared with preceding year. This is caused by the outlay of £1,215 14s. 7d. in painting and decorating.

Museum.

Report of the Curator.

GENTLEMEN,—I have the honour to report that the Museum still continues to be largely used by the Examiners and Professors of the College.

The work of cataloguing the specimens in the Pathological Museum still continues. During the year all specimens have been removed from the bottles, and the old discoloured spirit in which they lay re-distilled. These specimens are now in process of being replaced in clean jars, and in fresh clear fluid. In addition, and with the aid of the students, for which an allowance has been granted, I have been able to examine a further couple of hundred specimens microscopically; many of these I found to be structureless, and hence quite worthless, owing to imperfect hardening and consequent maceration in the comparatively weak spirit in which they were "preserved."

Several new specimens were added during the year. The new specimens were presented by Mr. L. H. Ormsby (President), Dr. Craig, Mr. Conway Dwyer, Mr. Lane Joynt, Professor Scott, and Mr. W. Taylor.

Painting and Repairing of the College.

It was stated in last year's Report that the hall, front and back stairs, and the board-room, have been painted and decorated, new granite steps have been laid down at the front door, and the pavement of the hall repaired and made level, new electroliers have been put up in the board-room, hall, and front stairs, and all the pictures and busts cleaned.

The accounts for this work were all paid last October. They amounted with the architect's fees to £1,215.

If to this sum is added the £450 mentioned in last year's Report as having been spent on the repair of the roof and the cost of the new sewers, it will be seen that in the last two years the Council has spent over £1,600 on the College.

Address to His Majesty the King on the occasion of His Coronation.

On June 12th, 1902, the following address was presented to His Majesty on this most auspicious occasion. The Home Secretary wrote stating that His Majesty had been graciously pleased to receive the address:—

TO HIS MOST EXCELLENT MAJESTY EDWARD THE SEVENTH OF THE UNITED KINGDOM OF GREAT BRITAIN AND IRELAND AND OF THE BRITISH DOMINIONS BEYOND THE SEAS, KING, DEFENDER OF THE FAITH, AND EMPEROR OF INDIA.

MAY IT PLEASE YOUR GRACIOUS MAJESTY,

We, the President, Vice-President, and Council of the Royal College of Surgeons in Ireland, beg most respectfully to offer our loyal and cordial congratulations on the auspicious occasion of the Coronation of your Majesty and of Queen Alexandra as King and Queen of Great Britain and Ireland and of the Dominions beyond the Seas.

We feel pride in being the subjects of a Sovereign who has ever been foremost in all works of charity and mercy for promoting the comfort and alleviating the suffering of humanity, not only as exemplified by the life-long

interest taken in Hospital Extension and Efficiency, but also as instanced by such movements as the Housing of the Working Classes, the Tuberculosis Congress, and the Cancer Commission.

We rejoice that the happy event of the Coronation should have an additional splendour conferred upon it by the declaration of peace in South Africa, and the permanent extension of the Empire.

We trust the time is not far distant when your Majesties will visit this country as Ireland's King and Queen, and we venture to express our confidence that in no part of the realm would there be a deeper feeling of gratification and welcome.

As a Royal College of Surgeons we have for over a century been responsible for the training and education of a large number of Surgeons who have served, not without distinction, in your Majesty's Navy and Army.

We beg to assure your Majesty of our determination to maintain the loyal and dutiful relations with our Sovereign which have always characterised the Royal College of Surgeons in Ireland.

Address to the Lord Lieutenant.

On August 7th, 1902, the President and Council presented an address to Earl Cadogan when leaving Ireland, and, on October 2nd, 1902, to Earl Dudley, on his appointment as Lord Lieutenant.

Conjoint Licences.

The Council, in conjunction with the College of Physicians, have drawn up a new curriculum and regulations for their Conjoint Licences, which came into force in October last. A new curriculum and regulations have also been conjointly drawn up for the Diploma in Public Health, which came into force in January last.

Inspection by General Medical Council.

The Final Examinations, held in April—May, 1902, were attended by a Visitor and Inspector on behalf of the General Medical Council. In the Report they furnished to the General Council, the following clause occurs:—

That the Visitor and Inspector consider the Conjoint Examinations to be a fair and carefully conducted one, and that as regards its sufficiency it fulfils the requirements of the Medical Act.

Election of Representative of the College on the General Medical Council.

At the first meeting in February the Council again elected Mr., now Sir Charles, B. Ball to fill this office for the ensuing year.

Corporation Tax.

The Commissioners of Inland Revenue made a claim against the College under this head. The Council had to pay £106 5s. 11d. arrears of taxes for the years 1894-1902, and will in future be obliged to pay an annual tax of about £12, in addition to Income Tax and Municipal Taxes.

Delegates from the College.

The Council appointed delegates to represent this College at the Congress of the Royal Institute of Public Health, meeting in Liverpool, July, 1903 ; Congress of the Sanitary Institute, meeting at Bradford, July, 1903 ; and the International Congress of Hygiene and Demography, meeting in Brussels, September, 1903.

Cancer Research Committee.

In July, the two Royal Colleges in London invited this College to nominate a representative to serve on this Committee. The Council nominated the President.

Housing of the Poor.

On May 1st, 1903, the Council, at the request of Sir C. Cameron, permitted a meeting in aid of this most desirable object to be held in the College. His Excellency Earl Dudley took the chair on the occasion.

Annual College Dinner

was held on February 11th, 1903, at which the Lord Lieutenant, Earl Dudley, was present.

Votes of Congratulation.

The Council congratulated Sir Thomas Myles and Sir Charles Ball on receiving the honour of knighthood.

Barker Prize, 1902.

This Prize was won by R. G. Allen, a student in the College School.
